Angelwood Programs

For over 16 years, Angelwood has been caring for people with developmental disabilities in Northeast Florida. The agency is built upon the high quality of care that has become its hallmark. By providing superior services for area children and adults with developmental disabilities, Angelwood has expanded the kinds of services we offer, all in response to community needs. Today Angelwood services include:

Group Homes- Located in residential neighborhoods, the Angelwood group homes served 28 individuals by providing 24- hour awake supervision in a home setting. In addition to the personal assistance each person receives, staff in the group homes are trained to assist each person attain their personal goals and new life skills.

Residential Respite - Caring for a child with a disability creates more stress than most typical families experience. Angelwood offers respite for families who care for their child at home. Our goal is to re-energize families by providing a short break so that they can resume the important role they have in their child's life. Angelwood group homes provided 96 days of respite for area families last year, which can be for the day, weekend, or overnight.

Angelwood Summer Day Camp- is the highlight of the year for many school-age children with developmental disabilities throughout the city. Whether doing arts & crafts, playing sports, singing or hiking, the campers are engaged in meaningful summer fun that keeps their bodies and minds active. In partnership with Hendricks Avenue Baptist Church and the LSS Kids Café program, our Summer Day Camp served 35 campers per week for 5 weeks.

Behavior Services- a Behavior Analyst is available to assess behaviors, develop programs and monitor progress toward goals. 37 individuals received behavior services through Angelwood.

Adult Day Training (ADT)- provides supervision and training for adults with cognitive or physical limitations to learn work related skills. In partnership with Lakewood United Methodist Church, this arts- based program served 12 people and continues to grow.

Supported Employment- served 28 individuals last year and is designed for people who need added structure and support to achieve and maintain competitive employment in their community. Angelwood offers employment services through the Florida Department of Education, Vocational Rehabilitation and through the Agency for Persons with Disabilities.
